




历届全球人居环境论坛年会时空线路图 (2005-2024)

会议介绍 CONFERENCE INTRODUCTION

一、会议背景

世界政治分裂、社会两极分化、经济不安全、文化疏远和环境不可持续等危机日益加剧,这迫切需要协作性领导力、突破性创新和集体行动,为所有人创造一个包容、韧性和可持续的未来。

身处一个城市星球,城市是实现可持续发展和应对气候变化的主战场。到 2030 年,在城市中采取自然友好的方法可以创造数万亿的商机。城市地区在应对上述危机和实现可持续发展目标方面也能取得最大进展,以加速人类发展、保护地球健康和创造持续繁荣。

具体而言,在应对多重危机挑战、实现可持续发展目标和气候目标过程中,创新发挥着举足轻重的作用。创新塑造了并将继续重塑城市和人居环境。以人工智能和互联网为代表的数字技术和新能源技术等重大创新科技正在并将极大地推动各领域的创新,进而改变未来世界。融合创新也变得愈加重要,它不仅关注技术创新,还强调治理、商业模式、流程和融资等方面的创新。与此同时,创新通常始于本地,通过复制、加速与规模化可以提高效率、降低成本并提高所有人的生活质量。

地方领导力是一种尚待挖掘的力量。联合国秘书长安东尼奥 • 古特雷斯强调: "地方权力的作用在很多方面甚至可能比国家权力更重要。当我们考虑如何使多边机构更加有效,并应对人类和地球当前和未来面临的挑战时,我们需要鼓励地方和区域当局的参与,听取他们的见解。可持续发展目标只有在每个城市都实现了,我们才算是真正达成了目标。"

具有前瞻性的地方政府和城市领导人具有独特的优势,可以通过以下方式利用融合创新的力量来改善治理并提高城市和社区的宜居性、复原力、繁荣和可持续性: 1)加快协同脱碳和脱钩进程, 2)创造以人为中心的、行人友好的公共空间, 3)在主要行业试验零碳和零废战略和技术,以及 4)扩大自然友好型策略和解决方案。

与此同时,联合国将于 9 月 22 日至 23 日在纽约举行 2024 未来峰会,就我们的未来应该是什么样子以及我们今天可以做什么来确保一个更美好的未来达成新的全球共识。在此重要背景下,作为世界上聚焦可持续城市与人居环境最

重要的会议之一,第十九届全球人居环境论坛年会暨新可持续城市与人居环境奖盛典(GFHS 2024)计划于 2024 年 10 月 24 日在美国纽约市隆重举办,庆祝 2024 "世界城市日"。本届年会主题为"增强创新和地方领导力,塑造可持续的城市未来"。

论坛将邀请各国政府官员、外交使节、联合国官员、国际组织负责人和高级代表、市长、商界领袖、知名专家、学者和青年领袖与会,重点通过创新和地方领导力的视角以及对此的需求,就发展、技术、环境和气候变化等紧迫问题进行富有成效的对话和探讨。论坛预计将形成一系列建议和成果共识。

I. BACKGROUND

The world is getting increasingly politically divided, socially polarized, economically insecure, culturally estranged and environmentally unsustainable, which extends a resounding call for collaborative leadership, groundbreaking innovation and collective action towards an inclusive, resilient and sustainable future for all.

On an urban planet, cities are a primary arena to deliver sustainable development and cope with climate change impacts. Cities are where nature-positive pathways can create trillions of business opportunities by 2030. Urban areas are the places in which the greatest progress can be made to resolve the above-mentioned issues of our ill-system, to rescue the Sustainable Development Goals (SDGs) and accelerate the transition sustainability for people, for the planet and for prosperity by 2030.

Specifically, in the course of addressing the multiple crises and challenges as well as meeting the SDGs and the climate goal, innovation plays a fundamental role. It has shaped and will continue to reshape our cities and human settlements. Major leading technologies represented by digital technologies, most notably Al and Internet, as well as new resource and energy technologies are and will greatly spur innovation in various sectors and transform the world. Integrated innovation which not only focuses on technologies, but also on governance, business models, processes, and financing, among others, is becoming essential. Meanwhile, innovation starts generally locally and can fuel greater efficiency, lower costs, and better quality of life for all, through replication, acceleration and scaling.

Local leaders are an untapped power to be unleashed. UN Secretary-General António Guterres stressed that: "the role of local power can even be more important than national power in multiple ways. As we consider ways to make multilateral institutions more effective, and to meet the current and future challenges facing people and planet, we need the perspectives and engagement of local and regional authorities. SDGs can only be reached if they are reached at each of the different municipalities."

Forward-looking local governments and city leaders are uniquely positioned to harness the power of integrated innovation to improve governance and enhance livability, resilience, prosperity and sustainability of cities and communities through a) accelerating decoupling and decarbonization in a coordinated manner, b) creating peopleoriented and pedestrian friendly public spaces, c) experimenting zero-carbon and zero-waste strategy and technology in the major sectors, and d) scaling up nature-positive strategies and solutions.

In the meantime, Summit of the Future 2024 will be held by the United Nations on 22-23 September in New York to forge a new global consensus on what our future should look like, and what we can do today to secure a better tomorrow. In this important context, the 19th Annual Session of Global Forum on Human Settlements--one of the most important conferences worldwide focusing on sustainable cities and human settlements-will take place at the United Nations Headquarters in New York on October 24, 2024, while celebrating the World Cities Day 2024. The theme for this session is "Invigorate Innovation and Local Leadership for a Sustainable Urban Future".

The Forum will engage national government officials, ambassadors, United Nations officers, international organization heads and senior representatives, mayors, business leaders, well-known experts, scholars, and youth leaders on collaborative and productive dialogue and deliberation on pressing issues of development, technology, environment and climate change, notably through the lenses of and needs for innovation and local leadership. The Forum is expected to put forward a series of recommendations and consensus.

新可持续城市与人居环境奖 NEW SUSTAINABLE CITIES AND HUMAN SETTLEMENTS AWARDS

"可持续城市与人居环境奖"(简称 "SCAHSA/飒飒奖",原名 "全球人居环境奖")是由全球人居环境论坛 (GFHS) 于 2005 年创立和颁发的一年一度的国际大奖,得到联合国环境规划署等联合国机构和国际组织的大力支持和指导。该 奖项旨在促进《2030 年可持续发展议程》、特别是其"目标 11"的贯彻,表彰推广获奖者在建设更加安全、绿色、有复原力、包容和可持续的城市与人居环境过程所取得的突出进步和宝贵经验,带动更多人参与和自觉行动。

该奖项评审标准植根于联合国《2030年可持续发展议程》和《新城市议程》,已经成功举办了十八届,获奖者来自世界各地,作为全球可持续城市未来最高奖项之一,产生了显著的示范效应。

借鉴有 120 余年历史的诺贝尔奖的成功经验, 2024 年 SCAHSA 奖全面转型, 升级为"新可持续城市与人居环境奖"(简称"新 SCAHSA/飒飒奖"),致力于成为全球可持续城市未来最高奖项之一。"新飒飒奖"将表彰和奖励可持续城市与人居环境领域,包括可持续发展和气候行动领域的杰出创新和地方领导力,并推广其先进的策略、技术、方法和成功经验。获奖者将在颁奖典礼上被授予证书、奖牌,并赠予奖金。这将激发获奖者的雄心和创造力,并改善其工作和生活条件,为可持续发展做出更大的贡献。

The Sustainable Cities And Human Settlements Awards (SCAHSA) (originally "Global Human Settlements Award") is an annual worldwide prize initiated in 2005 by Global Forum on Human Settlements (GFHS) and supported by UNEP and other UN agencies. The awards program aims to accelerate the delivery of UN Sustainable Development Goals, notably SDG 11, recognize and celebrate winners' remarkable progress and valuable experience in making cities and human settlements safer, greener, more resilient, inclusive and sustainable, and drive more to follow suit and take decisive actions on the ground.

The assessment criteria of SCAHSA is rooted in the 2030 Agenda for Sustainable Development and the New Urban Agenda (NUA). SCAHSA has been successfully held for eighteen years until 2023, with awardees coming from different parts of the world. It has become one of the most important recognitions for a sustainable urban future in the world, producing a significant demonstration effect.

Drawing on the successful experience of the Nobel Prize with 120+years of history, the SCAHSA in 2024 has been fully upgraded to the "New Sustainable Cities and Human Settlements Awards" (abbreviated as the "New SCAHSA"), aiming to become a global top prize for sustainable urban future. The "New SCAHSA" will recognize and reward outstanding innovation and local leadership in making sustainable cities and human settlements, including climate actions and sustainability practices, and promote their innovative strategies, technologies and approaches as well as successful experience.

全球人居环境论坛 (GFHS) 是具有联合国经社理事会特别咨商地位的国际非营利组织,也 是 501(c)(3) 项下免税的公益机构, 致力干建设全球高端对话与合作平台, 促进人人共享的可 持续城市与人居环境。原联合国安理会主席、联合国副秘书长及高级代表安瓦尔 • 乔杜里大使 担任 GFHS 主席。

GFHS 的主要工作包括:举办一年一度的论坛年会及学术会议;推动贯彻《2030年可持 续发展议程》、《新城市议程》和《巴黎气候协定》;促进和加强区域之间、政府和民间社 会在建设可持续城市和人居环境方面的交流合作: 研发和推广"国际绿色范例新城(IGMC)"倡 议与标准: 颁发"可持续城市和人居环境奖(SCAHSA)": 出版《全球最佳范例》杂 志 (WBPM) 、《全球人居环境论坛文集》及其他出版物。

多年来, GFHS 和联合国经济和社会事务部、联合国环境规划署、联合国人类住区规划 署、联合国开发计划署、世界气象组织、联合国贸发会议组织、联合国工发组织等联合国机 构以及亚洲开发银行、世界自然基金会、世界自然保护联盟、世界经济论坛、国际海洋学院 等知名机构进行了多项成功的合作。

全球人居环境论坛年会是世界上聚焦可持续城市与人居环境最重要的会议之一。自 2005 年起, 年会已经在五大洲和纽约联合国总部连续成功地举办了 18 届, 共有 323,000 多 名各国各界代表参加,并且曾作为2012年"联合国可持续发展大会"(里约+20峰会)和 2016年"联合国住房和城市可持续发展大会"(人居三)的关联/平行会议。

As a global non-profit organization recognized by the United Nations system, the Global Forum on Human Settlements (GFHS) is in the Special Consultative Status with ECOSOC, and is committed to providing a world platform for high-level dialogue and promoting sustainable cities and human settlements for all. Legally chartered in the State of New York, USA, GFHS enjoys the 501(C) (3) tax exemption qualification. Former Under-Secretary-General and High Representative of the UN Ambassador Anwarul K. Chowdhury serves as the Chairman of GFHS.

The main work of GFHS includes: convening the annual global forum on human settlements and other academic conferences; promoting the implementation of the "2030 Agenda for Sustainable Development", "New Urban Agenda" and "Paris Climate Agreement"; facilitating exchanges and cooperation between and within regions, governments and civil societies in the area of sustainable cities and human settlements; researching and developing International Green Model City (IGMC) Initiative and Standards; issuing the Sustainable Cities and Human Settlements Awards (SCAHSA); and producing sustainability publications, notably the World Best Practices Magazine (WBPM) and The Collection of Global Forum on Human Settlements.

Over the years, GFHS has accomplished a number of cooperation projects with the United Nations Department of Economic and Social Affairs, United Nations Environment Programme, United Nations Human Settlements Programme, United Nations Development Programme, United Nations Economic and Social Council for Asia and the Pacific, United Nations Economic Commission for Africa, International Telecommunication Union, the World Meteorological Organization, Asian Development Bank, World Wildlife Fund, International Union for Conservation of Nature, World Economic Forum, and other international organizations.

The Annual Forum has become one of the most important conferences worldwide focusing on sustainable cities and human settlements. Since 2005, GFHS has been convening its annual forums at the United Nations headquarters and on five continents for 18 consecutive years, and more than 323,000 representatives from all sectors of society took part in the forums. Among them, one annual session was held as an associated event of 2012 United Nations Conference on Sustainable Development (Rio+20 Summit) and another as a parallel event of 2016 United Nations Conference on Housing and Sustainable Urban Development (Habitat III).

瓦努阿图是一个美丽的国家,居住着美丽、可爱和自豪的人民。根据幸福星球指数,瓦 努阿图在 2006 年被评为世界上最幸福的地方。

瓦努阿图共和国自 1980 年独立以来一直是联合国成员。尽管经济规模不大,但瓦努阿 图与联合国所有其他成员国一样,与大国和强国享有平等的席位——一国一票。瓦努阿图通 过其驻纽约的代表团, 一直倡导国际合作, 促进可持续发展、人权、裁军以及自决权和非殖 民化。

代表团旨在确保联合国及其机构在迅速变化的全球环境中的相关性,并在冲突时期提供 对话论坛。此外,与所有小岛屿国家一样,该国的经济和生计,以及在一定程度上的物质生 存都受到气候变化的威胁。因此,瓦努阿图呼吁全球努力减少温室气体排放,将全球气温上 升幅度限制在 1.5 摄氏度以下。

Vanuatu is a beautiful country, inhabited by beautiful, lovely, and proud people. Vanuatu was rated as the happiest place in the world in 2006, per Happy Planet Index.

The Republic of Vanuatu has been a member of the United Nations since the year of its independence in 1980. Despite the modest size of its economy, Vanuatu, like all other member states of the United Nations, has an equal seat at the table right alongside the big and powerful - one country, one vote. Ever since then the country, through its Mission based in New York, has been an advocate for international cooperation for sustainable development, human rights, disarmament, and the right of self-determination and decolonization.

The Mission aims to ensure the relevance of the United Nations and its bodies in a rapidly changing global environment and a forum for dialogue in times of conflict. Furthermore, like all small island nations, the country's economy and livelihoods, as well as to a certain extent their physical existence are threatened by climate change. Therefore, Vanuatu calls for global efforts to reduce greenhouse gas emissions and to limit the rise of global temperature to well below 1.5° Celsius.

根据日本政府和联合国之间的协定,联合国区域发展中心 (UNCRD) 于 1971 年成立,致 力于促进发展中国家的可持续区域发展,重点是在全球化和分权化趋势背景下的发展规划和 管理, 以及对全球环境问题及其影响的日益关注。

联合国区域发展中心的愿景是创建人人共享的可持续的生活环境——安全、有保障、公 平、包容的发展,与自然和谐共处。根据新的发展议程——《改变我们的世界: 2030 年可 持续发展议程》,该中心的使命是帮助发展中国家向可持续发展道路过渡。区域发展规划和 管理是该中心优先考虑的有效方式,通过指导国家以下地区、国家和国际行动,以弥合一个 区域或不同区域之间的社会、经济和环境差异。

联合国区域发展中心在发展中国家的干预措施分为三个主要的相互关联和相辅相成的工 作领域: (a) 综合区域发展规划; (b) 可持续城市管理; (c) 知识管理。

UNCRD, which was established in 1971 based on an agreement between the Government of Japan and the United Nations, strives to promote sustainable regional development in developing countries with a focus on development planning and management in the context of globalization and decentralization trends, and the growing concern towards global environmental issues and their impacts.

UNCRD's vision is to achieve sustainable living environment for all - safe, secure, equitable and inclusive development in harmony with nature. The Centre's mission is to assist developing countries in their transition to sustainable development path in line with the new Development Agenda-Transforming Our World: The 2030 Agenda for Sustainable Development. Regional development planning and management is an effective set of tools that UNCRD is prioritizing to realize this mission through guiding subnational, national and international actions towards bridging the social, economic and environmental disparities within a region or among different regions.

UNCRD's interventions in developing countries are clustered under three main thematic interrelated and complementary areas of work-(a) Integrated Regional Development Planning; (b) Sustainable Urban Management; and (c) Knowledge Management.



安瓦尔•乔杜里大使 Ambassador Anwarul K. Chowdhury 全球人居环境论坛主席、联合国前副秘书长暨高级代表 Chairman of Global Forum on Human Settlements (GFHS) Former UN Under-Secretary-General and High Representative

安瓦尔•乔杜里在我们这个时代的关键性议题——和平、可持续发展和人权方面有着丰 富的经验,他是一名职业外交官、常驻联合国大使,先后担任联合国经社理事会副主席、联 合国安全理事会主席、联合国儿童基金会主席、联合国副秘书长,曾获"吴丹和平奖"、"联 合国教科文组织和平文化甘地金奖"和"联合国精神奖"。

乔杜里大使从 2008 年起担任全球人居环境论坛 (GFHS) 主席, 也是该论坛的发起人之 一。在他的领导下,全球人居环境论坛致力于"人人共享的可持续城市与人居环境",建设 世界可持续城镇化对话平台,获得了联合国经社理事会特别咨商地位。 论坛年会已经成功地 在世界各地举办了18届。

2007年7月, 乔杜里大使完成了他自 2002年3月开始担任的联合国副秘书长和联合国 最不发达国家、内陆发展中国家及小岛屿发展中国家高级代表的任期。 作为一名职业外交 官,1996-2001年,他一直担任孟加拉国常驻纽约联合国代表。他还担任过孟加拉国驻智利、尼 加拉瓜、秘鲁和委内瑞拉大使。

乔杜里大使分别于 2000 年和 2001 年担任两届联合国安全理事会主席。2000 年 3 月, 在 联合国安全理事会主席任职期间,他提出的倡议在政治观念上取得了突破性的进展,促使联 合国安全理事会开创性地通过了"关于妇女、和平与安全的第 1325 号决议"。 他创造性地 发起了联合国和平文化倡议,即 1999 年被联合国大会通过的具有里程碑意义的《和平文化 宣言和行动纲领》。 他还主持起草了联合国大会《世界儿童和平与非暴力文化国际行动十年 (2001-2010年)》的宣言。

As a career diplomat, Permanent Representative to United Nations, Vice-President of the Economic and Social Council of the UN, President of the UN Security Council, President of UNICEF Board, UN Under-Secretary-General, and recipient of the U Thant Peace Award, UNESCO Gandhi Gold Medal for Culture of Peace and Spirit of the UN Award, Ambassador Anwarul K. Chowdhury has a wealth of experience in the critical issues of our time—peace, sustainable development, and human rights.

Ambassador Chowdhurv is the co-founder and the Chairman of the Global Forum on Human Settlements (GFHS) since 2008. Under his leadership, GFHS is committed to Sustainable Cities and Human Settlements for All and to build the worldwide platform for dialogue on sustainable urbanization. GFHS has been granted the Special Consultative Status with ECOSOC, its annual session has been successfully held for 18 years around the world.

In July 2007, Ambassador Chowdhury completed his term as the Under-Secretary-General and High Representative for the Least Developed Countries, Landlocked Developing Countries, and Small Island Developing States of the United Nations, the post he held since March 2002. He was the Permanent Representative of Bangladesh to the United Nations in New York from 1996 to 2001. He also served as Bangladesh's Ambassador to Chile, Nicaragua, Peru, and Venezuela.

Ambassador Chowdhury served as President of the United Nations Security Council for two terms in 2000 and 2001. His initiative in March 2000 as the President of the Security Council achieved the political and conceptual breakthrough that led to the adoption of the groundbreaking UN Security Council Resolution 1325 on women and peace & security. He led a pioneering initiative at the United Nations on culture of peace which resulted in the adoption by the United Nations General Assembly in 1999 of the landmark "Declaration and Programme of Action on a Culture of Peace". He also initiated the declaration by the United Nations General Assembly of the "International Decade for Culture of Peace and Nonviolence for the Children of the World (2001-2010)".

Her leadership contributed towards making the College of Medicine a global partner and champion on social medicine research and programming.

Previously, Agnes Chimbiri-Molande worked for World Bank as Community and NGO Liaison Officer in Malawi in 1996. Prior to his appointment, Mr. Falefou served since 2020 as Secretary to the Government of Tuvalu, with job functions ranging from Principal Adviser to the Prime Minister to Principal Adviser to the Cabinet, to Head of Tuvalu's Public Service.

From 2019 to 2021, he was Principal Adviser to the Prime Minister in his capacity as Chair of the Pacific Islands Forum. From March 2020 to August 2021, he served as Chair of COVID-19 Regional Task Force, and he also co-chaired — alongside Tuvalu's Prime Minister — the country's national COVID-19 Task Force.

Among other functions performed during that period, Mr. Falefou was Chair of all meetings of the Pacific Australia Labour Mobility scheme, from 2019 to 2021. He was also Chair of the Projects Review Committee, Chair of the Lands Management Committee and Chair of the National Disaster Committee. From August 2019 to March 2020, Mr. Falefou served as Tuvalu's Permanent Secretary for Justice, Communication and Foreign Affairs. From August 2017 to July 2019, he was its Permanent Secretary for Communication and Transport. From January 2011 to January 2014, he was the country's Permanent Secretary for Foreign Affairs, Trade, Tourism, Environment and Labour, and from September 2006 to December 2008, he was its Permanent Secretary for Communication, Transport and Tourism.

Born in 1968, Mr. Falefou holds a doctoral degree from the University of Waikato in New Zealand, a master's degree in diplomacy and international public policy from the Australian National University and a bachelor's degree in public administration and management from the University of the South Pacific in Vanuatu, among other certifications.

Dr. Haifan Lin, Eugene Higgins Professor of Cell Biology, Professor of Genetics, of Obstetrics, Gynecology, and Reproductive Sciences, and of Dermatology, Founding Director of Yale Stem Cell Center. Dr. Lin's work is focused on the self-renewing mechanism of stem cells, using Drosophila germline stem cells, mouse germline stem cells, mouse embryonic stem cells, Hydra, and planarian stem cells as models. He also studies germline development and stem cell-related cancers.

Dr. Lin received his B.S. degree from Fudan University (1982) and his Ph.D. degree from Cornell University (1990). Following his postdoctoral research at the Carnegie Institution of Washington, he joined the faculty of Duke University Medical School in 1994, where he rose to the rank of Full Professor. He founded and directed the Duke Stem Cell Research Program (2005-2006) and moved to Yale in 2006 to establish and direct the Yale Stem Cell Center, building it from just two labs to currently one of the largest stem cell research organizations in the world with 100 member labs. With Yale's support, he was the Founding Dean (Adjunct) of School of Life Science and Technology at ShanghaiTech University (2014-2022), where he established a world-class faculty and educational programs in the School.

Dr. Lin received many awards and honors, including the Jane Coffin Childs Fellowship for Medical Research (1990), American Cancer Society Junior Faculty Research Award (1996), the March of Dimes Basil O'Connor Scholar Research Award (1996), the David and Lucile Packard Fellowship for Science and Engineering (1996), the G. Harold and Leila Y. Mathers Award (2007, 2011, 2015), the American Society of Andrology Lecturer Award (2008), the Laura Hartenbaum Breast Cancer Foundation's Legacy for Hope Award (2009), the Ellison Medical Foundation Senior Scholar Award (2010), the NIH Director's Pioneer Award (2010), the NIH MERIT Award (2012), the Ray Wu Award (the highest honor by the Chinese Biological Investigators Society; 2013), and the Society for the Study of Reproduction Research Award (2015), and the Chinese Association for Science and Technology, USA, Outstanding Science and Innovation Award (2019). He is a Member of US National Academy of Sciences (2018-), a Member of American academy of Arts and Sciences (2018-), and a Fellow of the American Association for the Advancement of Science (2010-).

卡洛斯 • 莫雷诺是一位国际知名的研究员。他于 1959 年出生于哥伦比亚,自 1979 年起定居法国,现为法国巴黎 IAE- 潘提翁索邦大学的副教授、Chair ETI 的科学主任。

卡洛斯·莫雷诺的贡献因其独创性而得到国际认可,并已被纳入法国和世界各地的众多地方治理和城市转型项目中。他是国内和国际知名人士的顾问。他提出的"15分钟城市"概念诞生于巴黎,作为一种新的城市理念,融合了时间城市主义、时间乌托邦和地域情结,已传遍世界各地。

他的工作旨在促进我们的生活方式和城市空间的转型,并为21世纪城市、大都市和地区面临的主要挑战提供解决方案。

Carlos Moreno is an internationally renowned researcher. Born in Colombia in 1959 and based in France since 1979, he is today Associate Professor at the Paris Sorbonne Business School, Panthéon Sorbonne University where he is the scientific director of the "Entrepreneurship - Territory - Innovation" chair.

Carlos Moreno's contributions are internationally recognized for their originality and have been incorporated into numerous projects on local governance and urban transformation in France and worldwide. He is an advisor to national and international personalities. His concept of the "15-Minute City", born in Paris, has gone around the world as a new urban approach with chrono-urbanism, chronotopia, and topophilia.

His work aims to promote the transformation of our lifestyle and urban spaces, and to offer solutions to the major challenges facing cities, metropolises, and territories in the 21st century.

In June 2022, he launched the Global Observatory on Sustainable Proximities at the World Urban Forum WUF11 with UN-Habitat, C40 Cities, United Cities and Local Governments (UCLG) and other partners. In October 2022 he received the "Scroll of Honour" from UN-Habitat for the global development of his 15-minute city concept. In January 2023 he was appointed president of the scientific committee of the Italian Council of Architects, Urban Planners, Landscape Architects and Conservators.

Carlos Moreno is considered one of the 20 most influential people in Europe on the Green Agenda and the 10th most influential contemporary urban planner in the world.

爱德华·格莱泽是哈佛大学弗雷德和埃莉诺·格林普经济学教授,自 1992 年以来一直在哈佛大学教授经济理论和城市经济学。他还领导着美国国家经济研究局的城市经济工作组,共同领导国际增长中心的城市项目,并共同编辑了《城市经济学杂志》。

他撰写了数百篇有关城市、基础设施和其他主题的论文,并撰写、合著和合编了许多书籍,包括《城市的胜利》、《城市的生存》(与大卫·卡特勒合著)和《在美国和欧洲消除贫困:世界大不同》(与阿尔贝托·阿莱西纳合著)。

他曾担任陶布曼州和地方政府研究中心主任、大波士顿拉帕波特研究所主任、《经济学季刊》编辑和哈佛大学经济学系主任。他是美国国家科学院院士、美国艺术与科学学院院士、美国政治与社会科学院院士和计量经济学会院士,曾获美国社会科学研究委员会颁发的阿尔伯特·赫希曼奖。

他于 1988 年获得普林斯顿大学文学士学位,并于 1992 年获得芝加哥大学经济学博士学位。

Edward L. Glaeser is the Fred and Eleanor Glimp Professor of Economics at Harvard University, where he has taught economic theory and urban economics since 1992. He also leads the Urban Economics Working Group at the National Bureau of Economics Research, coleads the Cities Programme of the International Growth Centre, and co-edits the Journal of Urban Economics.

He has written hundreds of papers on cities, infrastructure and other topics, and written, cowritten and co-edited many books including Triumph of the City, Survival of the City (with David Cutler) and Fighting Poverty in the U.S. and Europe: A World of Difference (with Alberto Alesina).

He has served as Director of the Taubman Center for State and Local Government and the Rappaport Institute for Greater Boston, Editor of the Quarterly Journal of Economics, and Chair of Harvard's Economics Department. He is a Fellow of the National Academy of Sciences, the American Academy of Arts and Sciences, the American Academy of Political and Social Science, and the Econometric Society, and he received the Albert O. Hirschman prize from the Social Science Research Council.

He received his A.B. from Princeton University in 1988 and his Ph.D. in Economics from the University of Chicago in 1992.

The latest of those is named Chongqing 2035: Spatial and Economic Transformation for a Global City (English). He also cooperated with MOHURD to publish Chinese and English-language academic works such as "Cities and Forms", and was honored with the "Global Human Settlements Outstanding Contribution Award" in 2017.

Serge Salat holds three doctorate degrees in Economics, Architecture and History and Civilizations.

Jiacuo Rinpoche, a Buddhist practitioner and a Tibetan young philosopher, a member of the 12th CPPCC Committee of Sichuan Province, a board member of the China Population Welfare Foundation, and a initiator of the Charity Fund under China Population Welfare Foundation. Jiacuo Rinpoche is known as the most influential young Buddhist leader today, a pioneer of new media public welfare advocacy, and a promoter of ancient Himalayan civilization.

Jiacuo Rinpoche studied at Peking University and studied Oriental philosophy systematically under the guidance of Professor Lou Yulie. In 2011, the Charity Fund was established in Beijing. The Nepal, Yushu and many rescue alliances he initiated have become important partners of the UN humanitarian relief agencies in civilian relief. Later, he initiated the establishment of the International Youth Leadership Union in the West, became the chairman of the International Buddhist Youth Federation, and received an honorary doctorate from Sophia University in the United States.

In terms of spreading Buddhist culture, Jiacuo Rinpoche has traveled all over Asia, Africa, and Latin America. He is often invited to lecture at world-renowned universities such as Harvard University. He has authored "Everything is the Best Arrangement" and published more than 5 million volumes. He has more than 30 million fans and believers.

Mianyang Ruiyang New Materials Technology Development Co., Ltd. is a waste tire comprehensive utilization enterprise announced by the Ministry of Industry and Information Technology. It is also the largest waste tire recycling and modified rubber powder production enterprise in Southwest China. It has an annual processing capacity of 100,000 tons of waste tires and 65,000 tons of modified fine rubber powder. The main product is recycled rubber powder, covering 60 mesh, 80 mesh, 100-200 mesh and other series, which are widely used in waterproof membrane, asphalt modification, medical rubber gloves, home appliances, unmanned aircraft, aerospace and other fields.

The company always pays attention to technological innovation and upstream and downstream industrial chain cultivation.

First, pay close attention to talent training. The company pays great attention to the reserve and cultivation of talents. Through organizing technical training, carrying out joint training, supporting on-the-job training and other methods, it has cultivated a group of professional technicians and operators for the research and development and production of modified rubber powder, and established a talent team with strong theory, excellent business and high quality. Second, it attaches great importance to strengthening scientific and technological innovation, research and development and transformation. Relying on the joint efforts of industry, academia and research, the company has continuously strengthened the upgrading of technical equipment and environmental protection supporting capabilities. It has established close strategic cooperative relations with a number of scientific research institutions such as Tsinghua University, Sichuan University, and Southwest University of Science and Technology. Focusing on the room temperature preparation process of ultra-fine rubber powder, rubber powder modification, and modified rubber powder application, the company has carried out joint research on key core technologies, achieved a number of scientific research results, and obtained 4 invention patents. The original process was systematically upgraded and transformed by adopting technical equipment such as whole tire crushing, closed automatic material transportation, finished product automatic packaging, and DCS distributed control system. Environmental protection facilities such as combined floor-standing dust removal system, activated carbon purification system, and spray tower were introduced to achieve clean and green production, effectively reduce production costs, and improve operation quality.

The third is to jointly cultivate upstream and downstream industrial chains. The company has established stable production and sales cooperation relationships with a number of listed companies and large state-owned enterprises such as Oriental Yuhong Group and CNOOC, achieving sufficient resources for waste tires on the upstream supply side and insufficient supply of products on the downstream sales side, forming a strong market risk resistance.
